AN ORDINANCE OF THE TOWN OF PALM SHORES, BREVARD COUNTY, FLORIDA, AMENDING THE LAND USAGE CODE OF THE TOWN; AMENDING SECTION 154.064(B) RELATING TO WIDTH OF PARKING LANES; AMENDING SECTION 154.064(D) RELATING TO PARKING SPACE REQUIREMENTS; AMENDING SECTION 157.003, DEFINITIONS; ADDING A DEFINITION FOR NURSING HOME AND AMENDING THE DEFINITION OF DWELLING, SINGLE FAMILY, AND DWELLING UNIT OR LIVING UNIT; AMENDING SECTION 157.515 PERTAINING TO THE DEFINITION OF OFF STREET PARKING; AMENDING SECTION 157.225 (F) INCREASING THE MINIMUM LIVING AREA TO 1,200 SQUARE FEET; AMENDING SECTION 157.285 (B) AND (E) RELATING TO C-2 GENERAL COMMERCIAL; AMENDING SECTION 157.300 (B) AND (F) RELATING TO C-P COMMERCIAL PARKWAY; AMENDING SECTION 157.330 RELATING TO TR-1 MOBILE HOME PARKS; PROVIDING FOR CONFLICTS, SEVERABILITY, AREA ENCOMPASSED, CODIFICATION AND AN EFFECTIVE DATE.
